

# Terms and Conditions

## Swim22 2026 Merch Prize Draw

1. Entry to Diabetes UK prize draw is open to UK residents aged 18 and over who have an active Swim22 JustGiving Fundraising Page except employees of JustGiving, Blackbaud, Diabetes UK, or any related companies, their families, agents, or anyone professionally connected with the Prize Draw.
2. Participants will be automatically entered into the draw by logging fitness activity to their JustGiving page between 00:01 GMT 3<sup>rd</sup> April 2026 and 23:59 GMT 6<sup>th</sup> April 2026. All fitness activity will be tracked via your Swim22 JustGiving Page.
3. The personal data submitted by you in connection with the free draw will be used by JustGiving and Diabetes UK for the administration of the free draw. By signing up and participating in Swim22 you agree JustGiving and Diabetes UK may send you updates about the free draw. JustGiving and Diabetes UK will not contact you about our other activities unless you have already opted into such communications or you amend your contact preferences to allow us to do this.
4. There will be ten (10) prize draw winners.
5. The winners will be picked at random and will receive one Swim22 swimming cap and one Diabetes UK t-shirt per winner.
6. The winners will be selected at random from all eligible entries within 7 days of the closing date. To notify the winner, a representative from Diabetes UK will be in contact via telephone and/or email.
